- be shown at the March 30, 2017 event at the Basketball Hall of Fame.

Submitted and eligible PSA videos will:

- be broadcast on line;
- be recognized at the March 30, 2017 event.

*******REQUIREMENTS FOR SUBMISSION*******

- Deadline for Submission is march 10, 2017;
- All entries must have a "title slide" in the video that identifies the name of the PSA;
- All entries must be submitted on DVD, CD, flash drive or email;
- The disc, flash drive, or email must be labeled with the name of the school and the title of the PSA.

Content limitations

PSA submitted:

- Cannot include copyrighted music (original music accepted)
- Cannot include clips from movies, television shows or music videos
- Cannot include profane language, nudity, sex, weapons or depict excessive violence
- Cannot reference any commercial product or advertiser
- Cannot have actors wearing clothing with logos or any other commercial reference
- Cannot depict scenes of substance abuse or sexual activity

Should not identify the school district or town through clothing, signage or logos

***Sound and visuals must be clear**

PSAs must be original and communicate the dangers of impaired driving. Videos should be inclusive in terms of gender and sexual orientation and should communicate a message about safety.

The Hampden District Attorney's Office reserves the right to determine the eligibility of any project.
