Furthermore, I agree to waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall extend to all claims, material or otherwise, which the person giving the release does not know of suspect to exist at the time of executing the release. I understand that this agreement may be assigned at any time by the Released Parties.

3. I understand that this Release is intended to be as broad and inclusive as permitted by law, and I agree that if any portion of this Release is deemed invalid, the remainder will continue in full force and effect. I further understand that this Release is to be interpreted under the laws of the state where the Station(s) is/are licensed, and I submit to the jurisdiction of the courts within the same state and waive all objections to the jurisdiction or venue of such courts. This is the entire agreement between the parties, and I am not relying on any promises or statements other than contained herein.
